Redraw Terms & Conditions

- 1.2 You may only redraw an amount no more than the difference between:-
 - (a) the actual balance of your account, and
 - (b) what would have been the balance of your account had you only made the repayments required by your loan contract
- 1.3 We may allow or refuse a redraw transaction in our absolute discretion.
- 1.4 Each redraw must be for a minimum amount of \$200-00.
- 1.5 The amount of the redraw will be debited to your loan account and will then accrue interest under the loan contract.
- 1.6 For the purpose of calculating repayments, we may assume that any amount that is or may in the future be available for redraw is redrawn by you.
